Kenneth Roland Voigt, age 92, of Alhambra, IL., died Sunday, November 19, 2006, at Community Memorial Hospital in Staunton, IL.

Mr. Voigt was born at Marine, IL and grew up on a farm there. He graduated from Highland High School in 1932. On November 11, 1937, he married Dorothy R. Voigt, nee Gilomen, who passed away 11/27/1996. He had worked for the old St. Louis Dairy in St. Louis and continued to live and work in St. Louis for the first five years of his married life. He and his wife moved to their farm northwest of Marine, IL in 1942 where he dairy farmed for over 20 years, also raised livestock and grain farmed. He retired in 1977. Mr. Voigt had served as Supervisor for Marine Township and served on the Madison County Board. He was on the Highland Community Schools Board when the rural districts consolidated. He and his wife enjoyed traveling; Kenny was always visiting with friends over coffee or at a sale.
